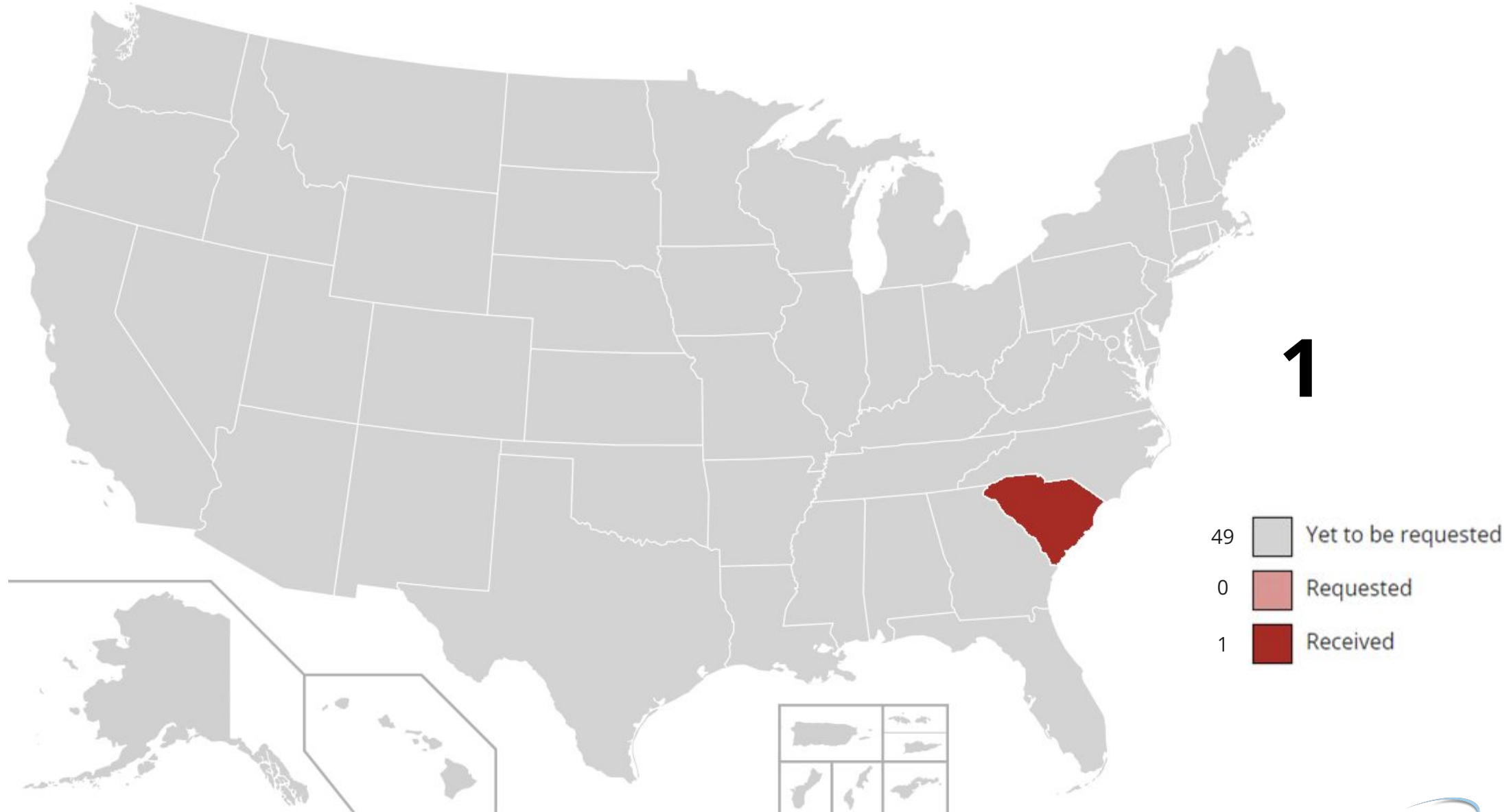

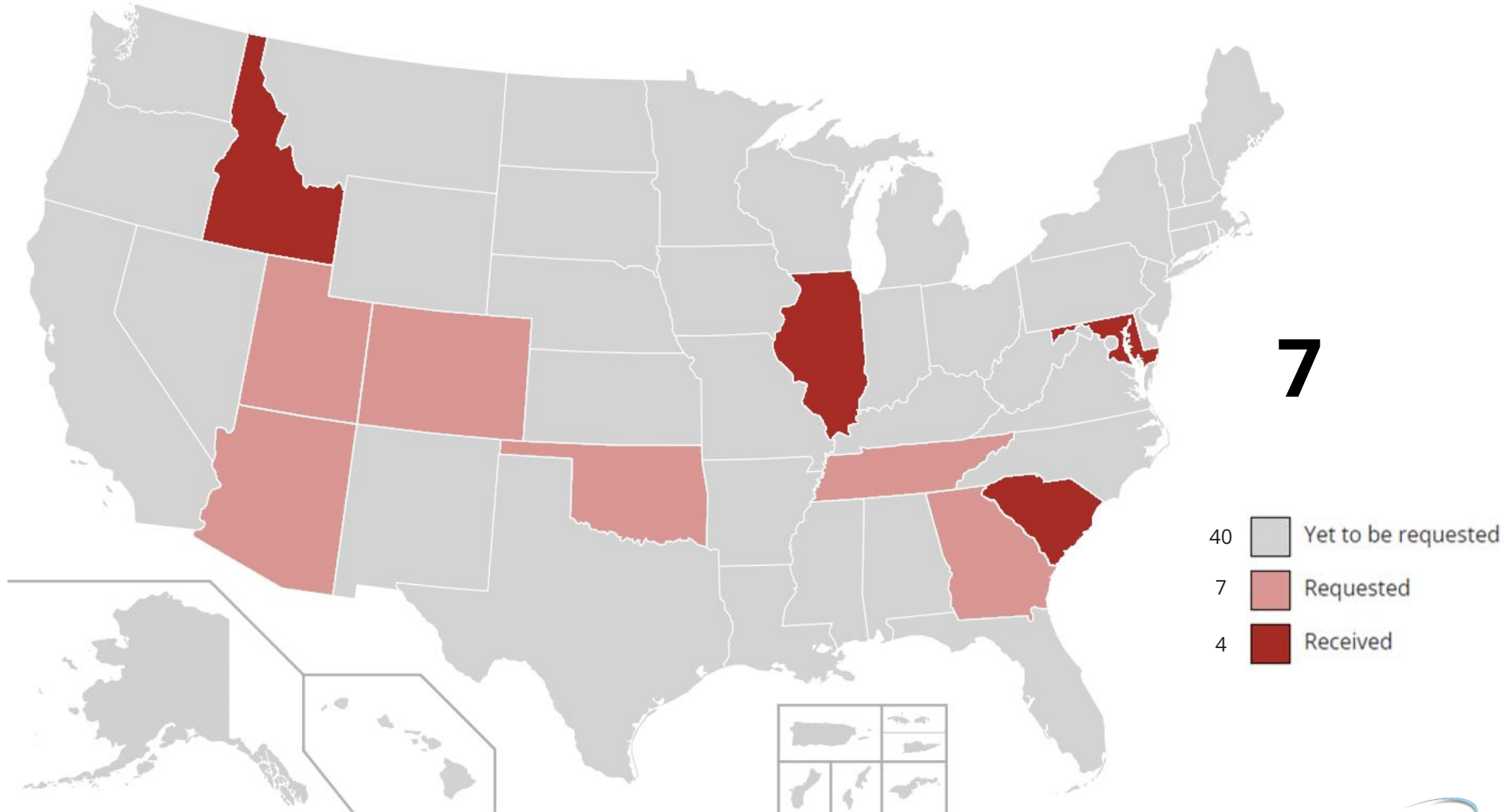

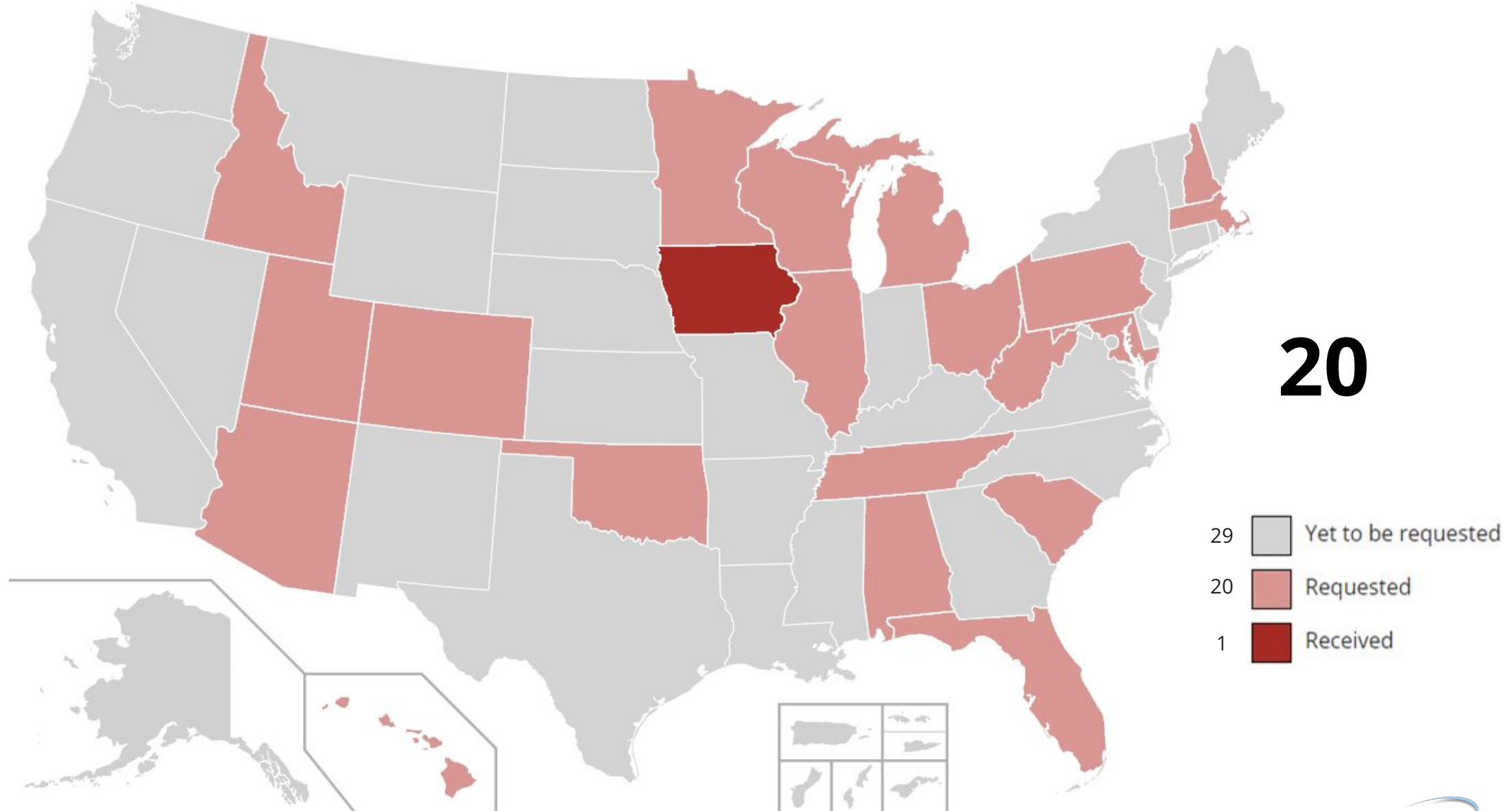

California:

Timing. Proclamation Requests 90 Day notice.

Sponsored and Evaluated by the State agency under which the proclamation topic falls (e.g., education, commerce). The agency works directly with the requestor to determine if the agency will sponsor the proclamation.

- CA University System or State Government.

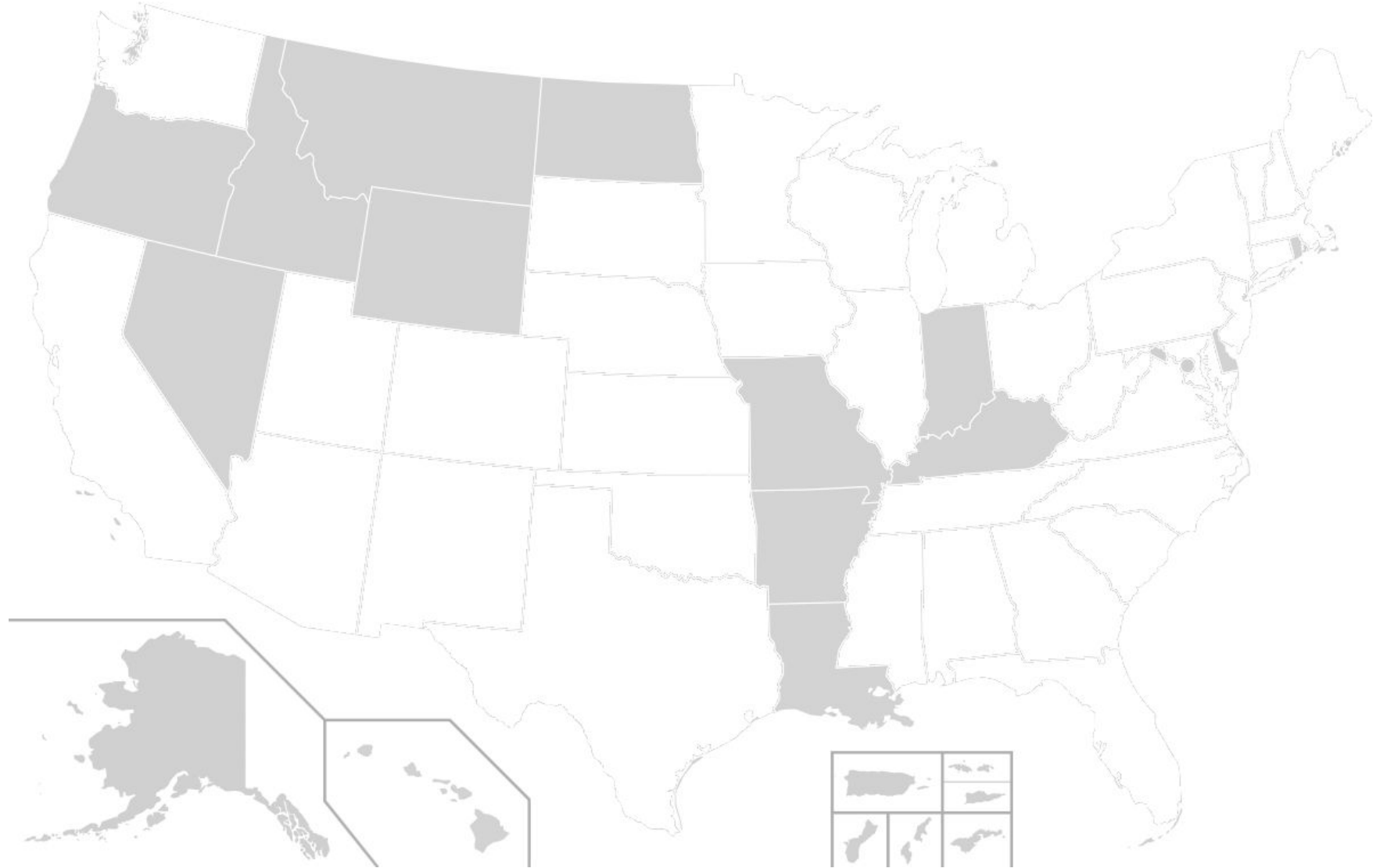

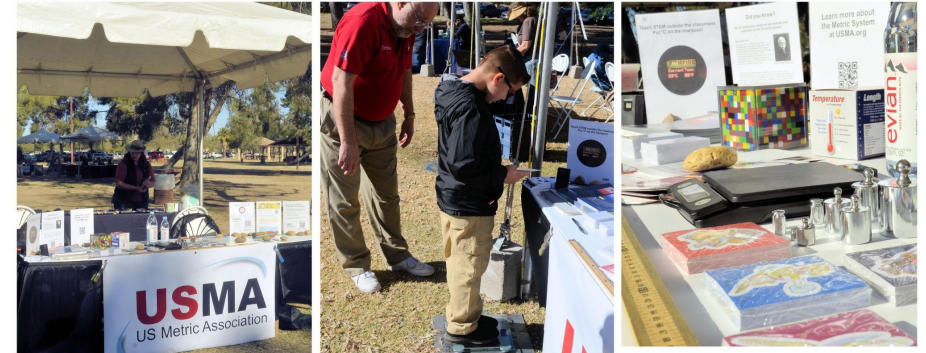

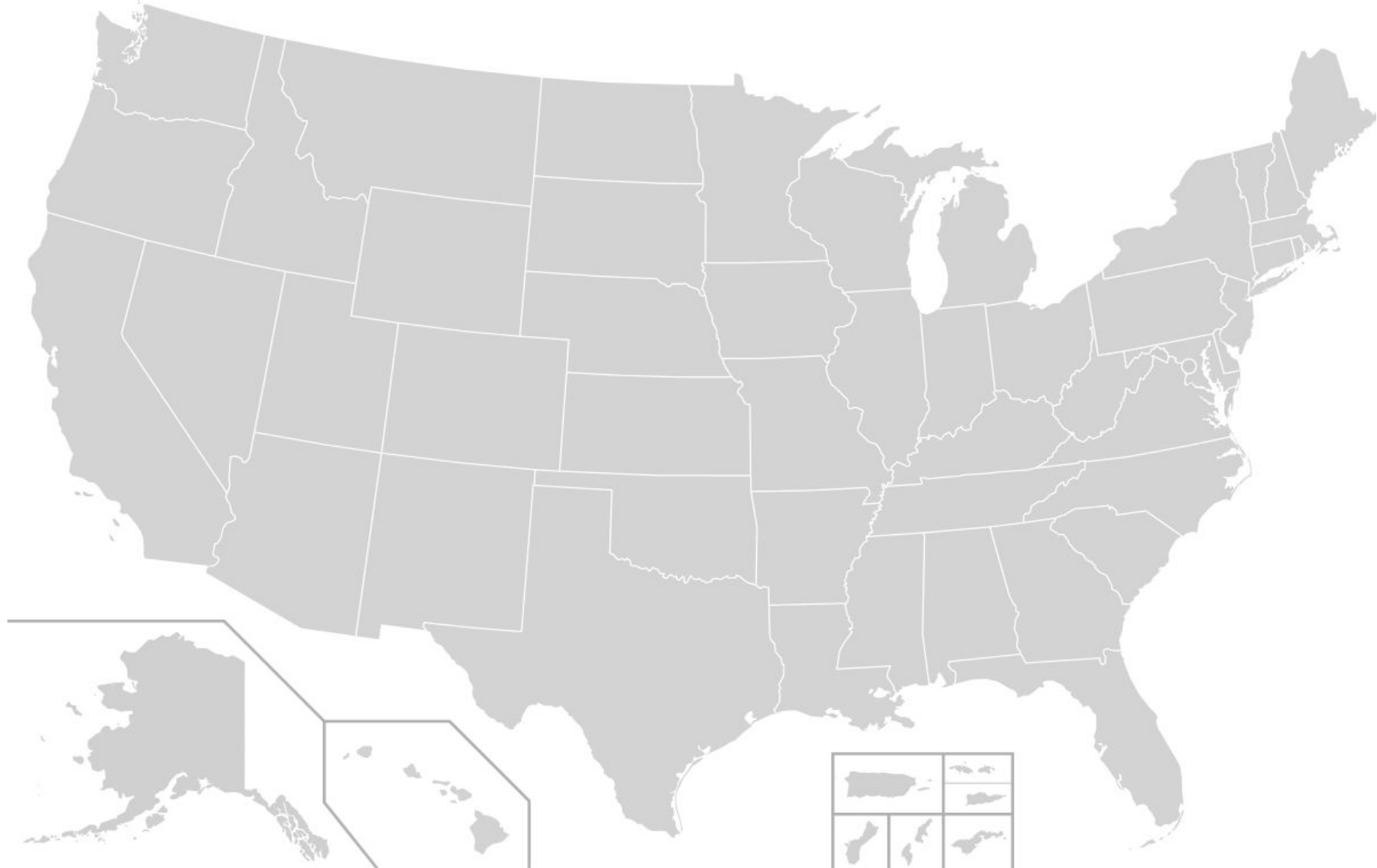
